Textual Information()	<p>In pursuance of Section 90 of the Companies Act, 2013 read with Rule 8 of the Companies (Significant Beneficial Owners) Rules, 2018, these Rules shall not be applicable to the extent the shares of the reporting company is held by its holding reporting company. Accordingly, with respect to the shareholding pattern of the Company as on March 31, 2020, HAL Offshore Limited (body corporate) is the Holding Company of the Company which holds 69.57% of equity shares of the Company. It may be noted that as per the shareholding pattern of the Company as on March 31, 2020, no individual indirectly holds more than 10% of the shares / voting rights / right to distributable dividend in the Company as provided under the provisions of the Companies Act, 2013. In view of the above and as per the cited provisions of the Companies Act, 2013, the Company (Reporting Company) has already filed the required Form BEN-2 with Ministry of Corporate Affairs and intimated the Corporate Identification No. (CIN) of HAL Offshore Limited (Holding Reporting Company) along with the required declarations received in this regard from the Holding Reporting Company. Pursuant to the above, the Company does not have any specific individual (natural person) identified as SBO during the quarter ended March 31, 2020. Any changes in this regard shall be duly intimated to the stakeholders.</p>
Textual Information()	<p>With respect to Serial No. A(1)(a) - Mr. Sanjeev Agrawal, Chairman and member of Promoter Group of the Company held 2,21,877 equity shares of the Company as on December 31, 2019. The same had been disclosed in the shareholding pattern of the company submitted to the stock exchanges for the quarter ended December 31, 2019. During the quarter ended March 31, 2020, Mr. Sanjeev Agrawal acquired additional 1,73,599 equity shares of the Company, aggregating his shareholding in the Company to 3,95,476. The details of said acquisition in prescribed format had been intimated to Stock Exchanges on March 26, 2020 pursuant to regulatory requirements. However, as per the download of aggregate shareholding under various categories as of end of day of March 31, 2020, as received from the Depositories, the aggregating shareholding of Mr. Sanjeev Agrawal was 3,95,466, a difference of 10 shares, primarily understood due to settlement cycle of Depositories. Accordingly, the same has been disclosed in this shareholding pattern to avoid any mismatch of holding in other categories of shareholders and the total number of issued, subscribed and paid-up shares of the Company.</p>
